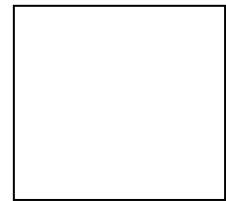

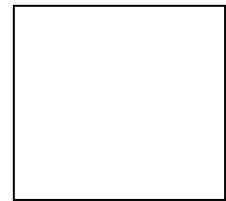

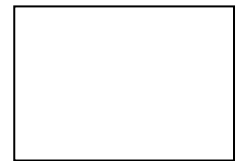

1. You should use this form **ONLY** if you are prepared to offer a lower price for a group of contracts than the sum of your tenders for the individual contracts. A separate form **MUST** be submitted for each "Combination"
2. To complete the form, enter the contract numbers you wish to combine in the boxes. Enter the minimum vehicle capacity you intend to use. Under each contract delete either Y or N to indicate whether you will provide an age-restricted vehicle. Remember on L.B.S. contracts you **must** comply with the age restriction indicated on the Schedule 1. Where you combine school services with local bus services you should indicate if the school service would be operated with an age restricted vehicle.
3. The basis of a combination price must be: All Local Bus Service contracts (LBS) **Total.....**: All Home to School Transport service contracts (H to S) **Daily.....**: Combination of both (LBS and H to S) **Total**
4. Where any contract provides services to more than one school then an annual cost must reflect the total cost of operating each day any of the schools is open.
